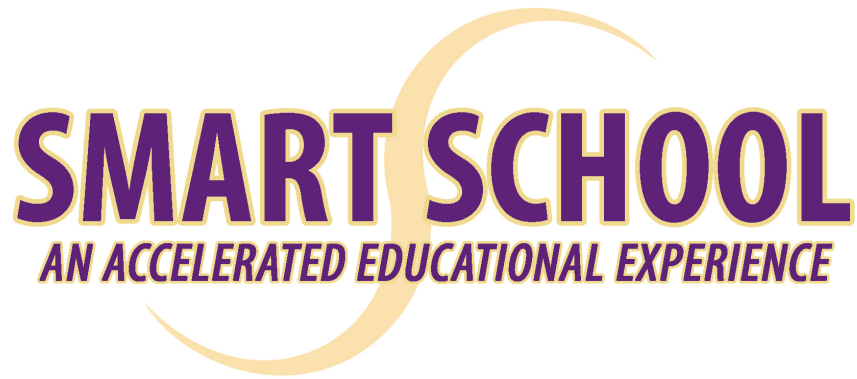

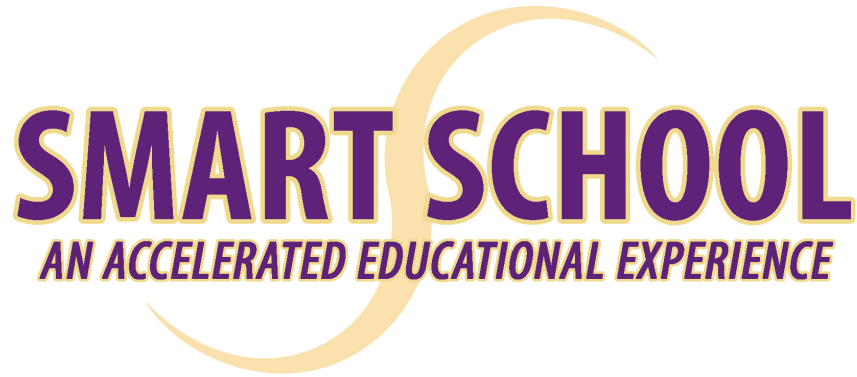

This contract shall be governed by the laws of the State of Oklahoma in Muskogee County and any applicable Federal Law.

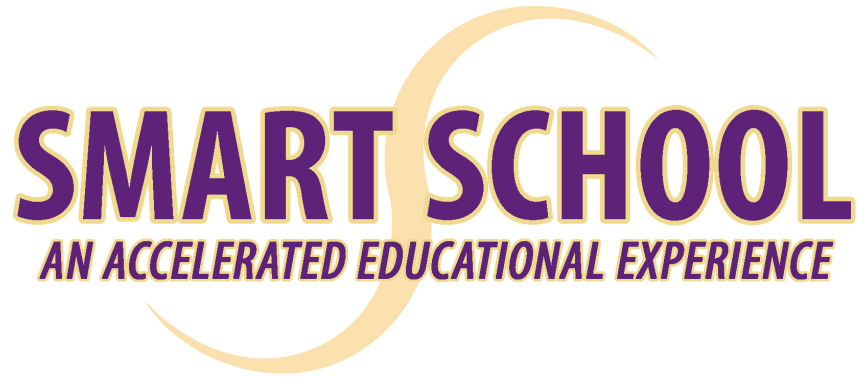
